## 1. Introduction

This document sets out the guidelines for participating in Grenoble Ecole de Management Open Call, part of the DIGI-ME project - a European initiative funded under the Digital Europe Programme, Grant Agreement number: 101123009, Call identifier: *DIGITAL-2022-SKILLS-03–Specialised* education programmes in key capacity areas.

In addition to this document, applicants are invited to become familiar with the DIGI-ME [website](https://digime-project.eu/) and the additional documentation available.

## 2. About DIGI-ME

The DIGI-ME project, co-funded by the European Union, aims to build and sustain a dynamic community of innovators ready to address Europe's emerging challenges. Through strategic collaboration with Higher Education Institutions (HEIs), technology parks, research centres, and SMEs, we are developing the Digital Ecosystem for Transformative Innovation (DETI), which is a collaborative hub that connects expertise, delivers high-quality learning experiences, and offers meaningful opportunities for learners and professionals in the digital age. ## 3. About DIGI-ME Grenoble Ecole de Management Open Call offer

The DIGI-ME Grenoble Ecole de Management Open Call presents a valuable opportunity for students aspiring to advance their advanced digital skills in fields related to the digitalisation of innovation, entrepreneurship and international management.

### 3.1 Funding and Awards

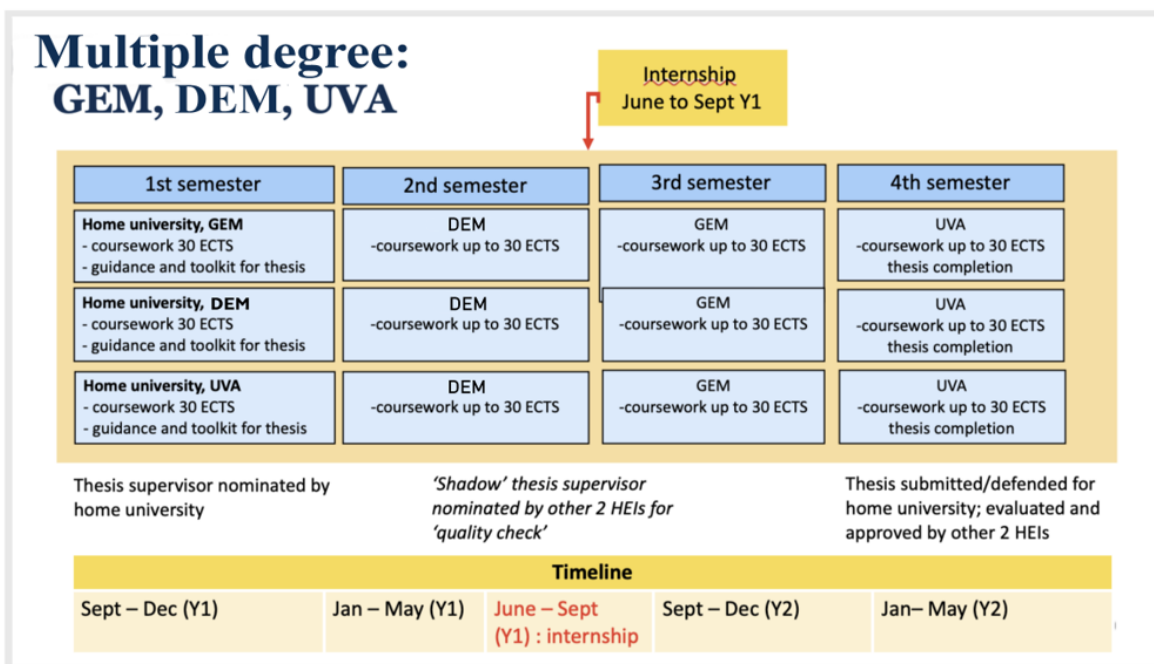
Through this call, up to ten (10) selected candidates will receive a scholarship to support their DIGI-ME learning path of the triple degree programme exchange with the **University of Pavia** and with the **University of Vaasa**.

- **Award type:** Scholarships are provided as a lump sum to support their triple degree programme at the University of Pavia and the University of Vaasa as part of the DIGI-ME educational offering.
- **Financial value:** Each selected beneficiary will receive a lump sum as indicated in the call for application.
- **Payment mechanism:** The DIGI-ME scholarship is paid in two instalments: a first tranche equal to 80% of the total estimated amount of the scholarship; a second tranche with a balance of 20%, paid at the end of the mobility, subject to verification of compliance with the conditions indicated above.
- Disbursement is subject to signing the mobility agreement, confirmation of enrolment, and compliance with all eligibility and reporting requirements outlined in the Open Call.
- Acceptance of the mobility period constitutes a formal commitment by the candidate. Cancellations must therefore be limited to serious and duly documented cases of force majeure. Any cancellation of the assigned mobility period must be communicated in writing to the DIGI-ME Coordinator ([digi-me@unipv.it](mailto:digi-me@unipv.it)), with GEM Global – DIGI-ME Section ([digime.mobility@grenoble-em.com](mailto:digime.mobility@grenoble-em.com)) in copy, must be adequately justified, and must be submitted promptly. Cancellation entails the refund of any financial contributions already received. The reason for the cancellation and/or failure to communicate it may be evaluated for the purposes of possible exclusion of the candidate from the subsequent selection process for the Grenoble Ecole de Management's international mobility programs.

### 3.2 Eligible Grenoble Ecole de Management Programme

The call targets students who wish to participate in the triple degree programme with the University of Pavia and the University of Vaasa at Grenoble Ecole de Management for the upcoming 2026-2027 and 2027-2028 academic years. The proposed mobility will be carried out in two phases: from January to June 2027 at the University of Pavia (Italy) and from January to May 2028 at the University of Vaasa (Finland).

The mobility scheme can be defined as follows:



DIGI-ME scholarships are available for Grenoble Ecole de Management students matriculated in academic year 2026-2027 in the Master's in Advanced Studies in Management (DESMa) or MSc Management in Business with specializations

#### DIGI-ME Course Selection Requirements:

To fulfil DIGI-Me project requirements, applicants are supposed to select courses from the University of Pavia, Grenoble Ecole de Management and University of Vaasa DIGI-ME educational offering for the academic year 2026-2027 and the academic year 2027-2028. ### 3.3 Application Period

Applications will be accepted from **19 August 2026 (09:00 CET, Brussels time) until 19 October 2026 (18:00 CET, Brussels time)**.

#### 3.3.1 Application Process

To ensure a seamless experience for all candidates, the DIGI-ME scholarship at Grenoble Ecole de Management follows a structured process. The **initial stage focuses on the competitive evaluation** of your application.

- **Formal Submission:** Applicants must submit all required documentation through the [dedicated form](#) within the designated call period.
- **Academic Evaluation:** A dedicated selection committee will review your profile, focusing on your academic excellence, professional background, and motivation to join the DIGI-ME educational path.
- **Selection Notification:** Successful candidates will be officially notified of their selection as DIGI-ME scholarship beneficiaries.

**Once you have been selected as a beneficiary for the scholarship**, the transition to the Grenoble Ecole de Management begins.

1. **Official Invitation:** Beneficiaries will receive a formal invitation from Grenoble Ecole de Management to join the triple degree programme at the University of Pavia and the University of Vaasa.
2. **Administrative Support:** Following your invitation, GEM Global, the **Mobility Service at Grenoble Ecole de Management** will contact you directly. They will serve as your primary point of contact, providing expert guidance through the formal enrolment process and ensuring your mobility semesters are correctly registered.
3. **Enrolment Completion:** Under the guidance of GEM Global, you will complete the necessary steps to be officially recognised as an exchange student at Grenoble Ecole de Management. For further details please refer to Section 7.

## 4. About GEM Scholarships for DESMA and MSc Management in Business with specializations programme

### 4.1 Objectives

The scholarships will support students to undertake their triple degree programme at both the University of Pavia and the University of Vaasa, according to the Course Selection Requirements outlined in Section 3.2. The scholarship will provide a lump sum to economically support the student in paying his/her tuition fees during the triple degree exchange programme. The courses are associated with the Master's in Advanced Studies in Management (DESMA) or MSc Management in Business with specializations

## 5. Eligibility Criteria

All applicants must meet the following general requirements to be considered eligible for the DIGI-ME Grenoble Ecole de Management Open Call. An eligibility check will be conducted to discard non-compliant proposals.

### 5.1 General Eligibility Conditions

#### 5.1.1 Academic/Professional Background

Applicants must be enrolled in one of the following DIGI-ME master's programmes at Grenoble Ecole de Management:



- MSc Managing with Data and Artificial Intelligence;
- MSc in Innovation and Entrepreneurship;
- MSc in Management in International Business;

Applicants must be:

- Enrolled for the academic year 2026–2027;
- Full-time students;
- Not on academic leave.

### 5.1.2 Nationality

Applicants must be a passport holder from an EU/EEA countries or Digital Europe Programme (DEP) associated countries (the full list is available [here](#)).

### 5.1.3 English Language Competency

All applicants must demonstrate certified English language proficiency with an official score report from one of the following tests:

- TOEFL IBT: 80
- IELTS Academic/IELTS Indicator: 6.0
- Cambridge English (Proficiency/Advanced/Business Higher): Grade A,B or C
- Duolingo English Test: 100
- Bachelor's degree was fully taught through the medium of English (official proof required)

**Note:** Documentation for the English language competency is not required for native English speakers. English is the official language of both the DIGI-ME Open Call and the entire master's programme. Applications submitted in any other language will not be considered.

### 5.1.4 Double funding

According to European Union's rules, it is forbidden to receive double support for the same incurred costs. Hence, the scholarship covered by this call is INCOMPATIBLE with other EU funds allocated for the same purpose. All applicants must declare they have not received other European Union's funds in the [dedicated form](#).

## 5.2 Grenoble Ecole de Management Open Call Application Submission

The **online submission** form must be adequately filled in and submitted through the [dedicated form by the deadline](#) (19 August 2026 at 09:00 CET - 19 October 2026 at 18:00 CET).

### 5.3 Required Documents

The following documents must be submitted through the [dedicated form](#) by the deadline (19 October 2026 at 18:00 CET).

- **Transcripts of Records:** Transcripts for the passed exams and related grades (If the student has been studying at a foreign educational institution during the academic year 2025-2026, the study merits have to be provided according to existing regulations and practices of Grenoble Ecole de Management).
- **Curriculum Vitae (CV):** Detailed CV outlining academic history, professional experience, skills, and relevant achievements (no photo required; maximum 1 page).
- **Personal Statement/Motivation Letter:** Statement (maximum 2 pages) explaining the applicant's motivation, interest in the programme, and how their background aligns with the DIGI-ME path of the triple degree programme together with the University of Pavia (Italy) and the University of Vaasa (Finland).
- **English Language Competency:** Certified evidence of English proficiency meeting the specified minimum scores above.
- **Copy of passport or ID card:** Copy of a valid passport or identity card.
- **Optional:** Information on gender, age, and socio-economic status. In the event of equal scores, these factors may be positively considered during evaluation in line with Grenoble Ecole de Management's commitment to supporting a diverse student body.

## 6. Evaluation

### 6.1 Methodology

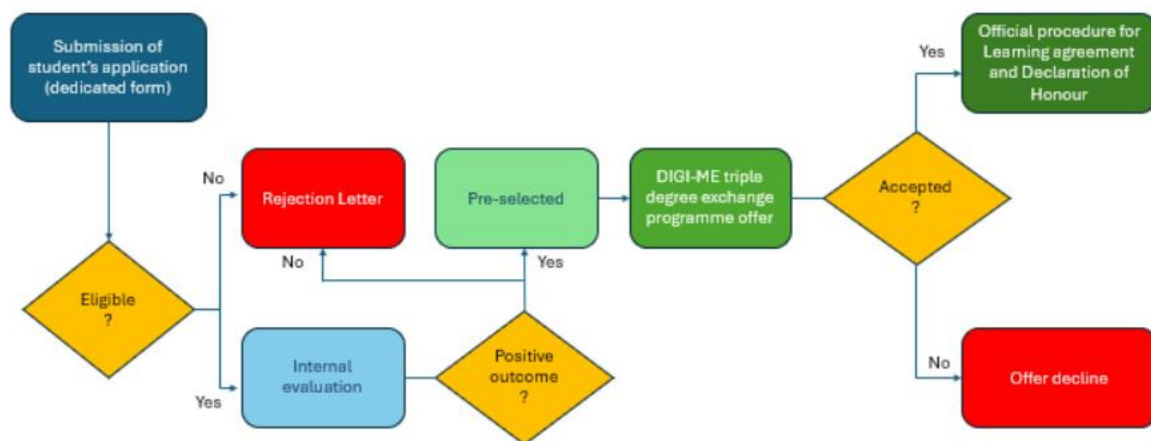
All applications must be submitted **EXCLUSIVELY** through the [dedicated form](#).

A complete list of applicants will be compiled, including basic information for statistical and transparency purposes (which will be also shared with the European Commission).

Application submission will close on **19 October 2026 at 18:00 CET**.

The evaluation process for the DIGI-ME Grenoble Ecole de Management Open Call is structured in a **three-step methodology** to ensure a fair, transparent, and thorough assessment of all applications as follow: **(1)** Admissibility and eligibility check; **(2)** Internal evaluation by experts; and **(3)** Ranking and selection of applicants. The process is represented in Figure 1.

#### 6.1.1 Admissibility and Eligibility Check

An initial admissibility and eligibility verification will be done to filter out and discard non-eligible applications. An application is only considered eligible if it meets all the eligibility criteria and requirements listed in Section 5, as well as the submission of all required documents, among others. Table 2. Grenoble Ecole de Management Open Call - Eligibility check presents the Eligibility checklist.

This eligibility check enables the establishment of a shortlist of applications to be evaluated in the next step of the evaluation process.

Applications marked as non-eligible (for not meeting one or more of the eligibility criteria) will receive a rejection letter with a justification.

### 6.1.2 Internal Evaluation by Experts

Applications that pass the eligibility check will undergo an internal evaluation, conducted by a panel of three experts from Grenoble Ecole de Management. This approach ensures a fair, impartial, and thorough assessment of each application, leveraging the diverse expertise within the faculty.

The collective judgement of the panel ensures that selections are based on recognised academic standards, the strategic objectives of the DIGI-ME initiative, and the specific requirements outlined in this Open Call.

#### 6.1.2.1 Evaluation Criteria and Scoring

Only eligible candidates will be evaluated. Successful candidates must reach an **evaluation threshold of 70%**.

DIGI-ME and Grenoble Ecole de Management are committed to promoting diversity, social and economic equality, and gender balance in all aspects of this open call. As part of our selection process, applicants will have the option to provide information on gender, age, and socio-economic background. In the event of equal scores, priority will be given in the following order:

1. Female applicants;
2. Applicants from low socio-economic backgrounds;
3. Applicants with disabilities;
4. Applicants from low-DESI (Digital Economy and Society Index) countries;

## 5. Applicants belonging to minority groups.

**Note:** All information provided regarding gender, age, and social background will be collected voluntarily and treated confidentially in accordance with GDPR/Data Privacy regulations. These data will be used solely for diversity monitoring and inclusive selection measures.

### 6.1.3 Ranking and Selection process

Following the experts' evaluation, all eligible applicants will be ranked according to their final assessment scores. Scholarships will be awarded based on this **order of merit**, beginning with the highest-ranked candidates.

Evaluation results will be compiled into an **Evaluation Summary Report (ESR)**. Applicants will be notified of the results via email, as follows:

- For Accepted Applicants: An Evaluation Summary Report together with an invitation to proceed to the enrolment phase and following steps.
- For Rejected Applicants: An Evaluation Summary Report for those who passed the eligibility check and underwent internal evaluation phase.
- A rejection letter to ineligible applications.

Successful applicants must **confirm their acceptance** of the placement offer **within five (5) business days** by replying to Grenoble Ecole de Management Global team – DIGI-ME section at [digime.mobility@grenoble-em.com](mailto:digime.mobility@grenoble-em.com).

#### 6.1.3.1 Reserved List Policy

If the number of qualified applicants exceeds the available places, candidates who meet the quality threshold but fall below the offer cut-off will be placed on a **reserve list**, ranked by score. Applicants on the reserve list may receive a waiver offer if selected candidates decline or fail to accept their offer within the stipulated deadline.

#### 6.1.3.2 Redress Process

Applicants who are not satisfied with the evaluation of their application, may submit a **written appeal within three (3) business days** of receiving their result. Appeals will be reviewed by a panel of two Grenoble Ecole de management Global team members, and one DIGI-ME Grenoble Ecole de Management team member.

Appeals are typically not allowed for disagreements with the academic judgment (score) or if the decision was based on the applicants misunderstanding of the application

instructions. Valid grounds for appealing scholarships offer decision generally focus on errors in the assessment process or claims of discrimination.

## 7. Programme Enrolment

To secure your DIGI-ME Grenoble Ecole de Management Scholarship, you'll need to formally accept the offer via email and sign the Declaration of Honour within five (5) business days of receiving the email from Grenoble Ecole de Management Global team – DIGI-ME section at [digime.mobility@grenoble-em.com](mailto:digime.mobility@grenoble-em.com)

The acceptance confirms your agreement to the academic and participation conditions designed to ensure your success in the programme. These conditions include:

- Completing your triple degree programme by May 2028.
- Adhering to the specified course requirements.

### Registration of DIGI-ME students from all 3 higher Institutions

When the students from University of Pavia, University of Vaasa and Grenoble Ecole de Management are selected, a list of successful applicants will be shared with Grenoble Ecole de Management GEM Global team. A manual registration application for each student will be done by GEM Global team in the nomination admission commonly used for regular incoming exchange students.

The following information will be required from each successful applicant:

- Name
- Gender
- Date of birth
- Citizenship
- Email address

Once students are registered, they will be asked to upload documentation and note which course they want to take in a comments field in the application. This process ensures the Grenoble Ecole de Management has received all the information needed to be able to register the candidates as students at Grenoble Ecole de Management.

## 8. Crafting your application

### 8.1 Step by step guide

This section provides a detailed walkthrough of the application process. To ensure

your application is complete, eligible, and submitted on time, please follow all steps carefully.

Carefully read the entire Guidelines for Applicants document to fully understand the terms and conditions of this Open Call.

**Step 2:** Prepare your documentation

Gather and prepare all required supporting documents in PDF format. Ensure no printing restrictions are applied to your files.

Mandatory Documents:

- Transcript of Records
- Curriculum Vitae (CV)
- Motivation letter (in [dedicated form](#), called as “Study plan for exchange abroad”)
- English Language Competency
- Copy of passport or ID card
- **Optional:** information on gender, age, and socio-economic status. In case of equal scores, these factors may be positively considered during evaluation, in line with the University of Vaasa commitment to supporting a diverse student body

If selected, you will be required to sign the following:

- Declaration of Honour
- Mobility Agreement
- Learning Agreement

**Step 3:** Complete and submit your application on the [dedicated form](#).

- Complete All Sections: Fill in all parts of the application form directly on the [dedicated form](#).
- Upload Files: Ensure all mandatory documents listed above are uploaded.
- Final Review: Thoroughly review your application before submission.
- Submit by Deadline: Applications must be submitted no later than 19 October 2026 at 18:00 CET. Late submissions will not be accepted.

## 10. General Information

### 10.1 Data protection

In order to process and evaluate applications, and manage project implementation, the DIGI-ME consortium will need to collect Personal and Industrial Data.

- A Data Protection Officer (DPO) has been appointed by UNIPV generally, to ensure compliance with data protection regulations, such as the General Data Protection Regulation (GDPR), and that personal data is collected, processed, and stored in a secure manner.
- The [dedicated form](#) design and operational procedures ensure that data is managed in compliance with the General Data Protection Regulation (EU) 2016/679 (GDPR).
- Each applicant will accept the [dedicated form](#) terms to ensure compliance.
- Apart from the [dedicated form](#), data will also be stored in the project repository on Microsoft Teams managed by the project coordinator at the University of Pavia in Italy (digi-me@unipv.it).
- Note that the DIGI-ME consortium must retain generated data until five years after the balance of the DIGI-ME project is paid or longer if there are ongoing procedures (such as audits, investigations or litigation). In this case, the data must be kept until their conclusion.

### 10.2 Confidentiality

Confidentiality obligations:

- Selected applicants are required to maintain confidential any project data, documents, invoices and other materials (in any form) during the implementation of the activities and for 5 years after project completion.
- This confidentiality period can be extended by agreement with the EC and the DIGI-ME consortium.
- Information shared during the project, whether written or spoken, is only considered non-confidential if DIGI-ME agrees and confirms it in writing within 15 days.
- Confidential information must only be used for project implementation, unless otherwise agreed upon.
- Any information shared during the application stage will be treated as confidential.

### 10.3 Origin of funds

Once an applicant has been selected for funding, they will be required to sign a dedicated Learning Agreement with Grenoble Ecole de Management. It is important to note that the funds attached to the DIGI-ME programme come directly from the funds of the Digital Europe Programme DIGI-ME project, which has been co-funded by the European Commission.

The Learning Agreement represents a commitment from the sub-grantees who will receive funding. The relationship between sub-grantees and the European Commission through the DIGI-ME project carries a set of obligations for the sub-grantees with the European Commission. These obligations will be outlined in the Learning Agreement, which the selected applicants will need to review and agree to. It is the responsibility of the sub-grantees to ensure that they fulfil these obligations, and the DIGI-ME consortium partners will provide guidance and support as needed. All selected applicants should carefully review the terms of the agreement and ensure that they are able to meet their obligations to receive the funding and successfully carry out their programme.

### 10.4 European Credit Transfer and Accumulation

#### System (ECTS)

The European Credit Transfer and Accumulation System (ECTS) is a tool of the **European Higher Education Area** for making studies and courses more transparent. It helps students to move between countries and to have their academic qualifications and study periods abroad recognised. ECTS allows credits taken at one higher education institution to be counted towards a qualification studied for at another. ECTS credits represent learning based on defined learning outcomes and their associated workload. ECTS enhances the flexibility of study programmes for students. It also supports the planning, delivery and evaluation of higher education programmes. It is a central tool in the **Bologna Process**, which aims to make national education systems more comparable internationally. ECTS also helps make other documents, such as the **Diploma Supplement**, clearer and easier to use in different countries.

ECTS has been adopted by most of the countries in the European Higher Education Area as the national credit system and is increasingly used elsewhere. For more information on ECTS please refer to the **European Education Area** website.
